**Introductory Local Law #4 of 2015 entitled ‘Taxation’  
(Senior Citizen & Gold Star Parent)**

**PLEASE TAKE NOTICE** that there has been introduced before the Town Board of the Town of Liberty in the County of Sullivan and State of New York, introductory Local Law No. 4 of the Year 2015, entitled “A local law amending Chapter 133, entitled ‘Taxation’, of the Code of the Town of Liberty.” The local law would (a) amend §133-11 of the Code of the Town of Liberty with respect to the senior citizen’s tax exemption by increasing income eligibility thresholds, extending the sliding exemption scale to run from 50% to 5% and providing that income shall not include veterans disability compensation as defined in Title 38 of the United States Code; and (b) add a provision to §133-18 of the Code of the Town of Liberty to make the veteran’s exemption available to Gold Star Parents.

A copy of the said local law is on file with the Town Clerk of the Town of Liberty, New York, where the same may be examined.

**PLEASE TAKE FURTHER NOTICE** that, pursuant to §20 of the Municipal Home Rule Law, a public hearing will be held on the aforesaid local law before the Town Board of the Town of Liberty, at the Town Hall, 120 Main Street, Liberty, New York, at 6:50 p.m. prevailing time, on January 19, 2015, at which time all interested persons will be heard.
