# DEPARTMENT HEAD REPORT WATER & SEWER DEPARTMENT November 7, 2016

- New backhoe was delivered on October 20<sup>th</sup> and was put into service on a water main break on October 21<sup>st</sup> on the White Sulphur Rd. The break was between the last two by the Arthur Shapiro residence and again, thanks goes out to Matt DeWitt and the Highway Dept for trucking assistance to put the County road back into service.
- 2. Working with three meter companies to get prices to replace two of the three sewer meters that have failed over the last two months. Manning is the manufacturer of all three, and they are obsolete now and must be replaced.
- 3. Second oxidation drain valve is here and scheduled to be installed the week of November 1<sup>st</sup> by Tam Enterprises at the Swan Lake Wastewater Plant.
- 4. Evan Decker has successfully passed his sewer final exam and is awaiting his certification card. Operators now on staff consist of 5 sewer and 4 water.
- 5. Stevensville well #3 has had upgraded meter installed by Layne Christensen and is scheduled to have the variable drive installed by Ted Marks Enterprise during the week of November 1<sup>st</sup>.
- Delaware Engineering and water Dept. met with Sullivan Co. DPW in Monticello
  to move foreward on the design of the lake crossing in the Stevensville Water
  District, and design of the Phase VII White Sulphur Rd. water main grant in the
  W.S.S. water District.
- 7. Potable water supply was given to the Youngsville Water District on the night of October 25<sup>th</sup>. Their operator contacted us and advised us that a well problem was occurring and they were awaiting their well people. Upon further investigation, it was found to have a broken valve at the well location that may have been vandalized and they are looking into it. We supplied two tractor trailer loads, (12,000 gallons) of water from the Sherwood Pump house, which allowed their district to stay in service overnight until their well could catch up
- 8. Full start up of the Loomis Sewer Plant is set for Monday October 31<sup>st</sup> and should have operators on site the full week to train Town personnel and check all operations for proper installation.

- 9. I am waiting on final approval of the sewer meter letter so it can be sent out. Are we going to send these out registered with a return receipt requested? When will quarterly billing start on new sewer meters and for the existing hotel meter? We have also sent a lits of Swan Lake users that will now be required to install meters.
- 10. Spoke with Brian on Tuesday November 1<sup>st</sup> about Board decision to replace Stacey's truck, or to make repairs to it. Truck is in the shop getting a list of repairs and the cost to keep it roadworthy for some length of time. I will bring the estimate to the meeting on Monday. Also discussed was the ongoing need for some kind of rag control at the Swan Lake sewer plant. Stacey spoke to people who worked on the Village sewer plant with their aeration problems and gace us a few ideas, but the rag problem has to be addressed prior to any aeration equipment addition. This company also stated to Stacey that with the elimination of the rags that are now plugging the existing jets during the summer might eliminate the need for more air addition.
- 11. Final drain valve at the Swan Lake sewer plant was installed by Tam Enterprises on Tuesday Nov. 1<sup>st</sup> and will complete the valving replacement planned for the 2016 season. We are refilling the ditch to check the jets for any more blockages and are planning on switching to switch ditches in late spring to clean the second ditch aeration jets prior to summer 2017 rush. We know that some are now plugged but draining and physical inspection of the six ports is the only way to know if they are open or plugged.
- 12. Any other matters that may arise prior to meeting.

In District Sewer Users

RE: Sewer Flow Meter

On September 6, 2016 The Town Board of Liberty enacted a Local Law amending the sewer use regulation in Chapter 121-29 of the Code of The Town of Liberty.

As stated in the amended code, any property connected to and discharging into a district sewer system in excess of 3,000 gallons of average daily flow of sewage in any given month, shall install a manhole and flow meter at the owner's expense.

Your property has exceeded the 3,000 gallons of daily flow and will require a flow meter to be installed.

Enclosed is a copy of the amended sewer code 121-29.

Flow meters must be installed and completed by September 1, 2017 to prevent violations to the property following the above date.

# SECTION I Amendment of Chapter 121 of the Code of the Town of Liberty

A. A new §121-10.1 is hereby added to Article IV of Chapter 121 of the Code of the Town of Liberty to read as follows:

"§121-10.1 Non-district users.

An owner of property that is located outside of an established sewer district of the Town may request that the Town Board of the Town of Liberty authorize connection to a district's sewage system. The determination whether or not to approve such request and authorize such connection shall be at the sole discretion of the Town Board and, in any event, shall only be considered if the district has adequate capacity available to accommodate and treat the proposed quantity of flow for the period of time requested. If approved, no such connection shall occur until a written agreement is entered into between the non-district property owner and the Town Board acting on behalf of the relevant sewer district, which agreement must contain the following provisions:

- A. The term of the agreement, including dates of commencement and termination and whether the agreement is renewable.
- B. The average daily flow per month to be received by the district for the term of the agreement.
- C. The location of the district's manhole where the property owner's non-district sewer line shall connect to the district's system.
- D. The property owner's agreement to install, prior to connection, at his, her or its sole cost and expense (inclusive of Town engineering and professional expenses), a manhole and flowmeter acceptable to the Town Board, the Administrator and the Town's engineer, in order to facilitate observation, sampling and measurement of waste as well as inspection by the Town. The manhole shall be located and the meter installed so as to be safe and accessible by Town personnel and constructed in accordance with plans approved by the Administrator. All maintenance, repairs and replacements thereof, and annual calibration of meters, shall be at the property owner's sole expense and performed by contractors approved in advance by the Town Board.
- E. A description of the type and nature of flow that is to be discharged into the district's system.
- F. The minimum amount of advance notice of early termination of the agreement by the Town in the event the limit of the district's capacity shall be reached prior to the end of the term of the agreement.
- G. The charge to the property owner per 1,000 gallons of flow received by the district shall not exceed the average residential rate charged to in-district users, which includes Maintenance and Operation (M&O) and Capital charges.

- H. The property owner shall be billed quarterly based on the actual flow recorded by the meter as read by the Town's personnel.
- In the event any amount billed by the Town remains unpaid after thirty (30) days of the date of the invoice, the property owner shall be charged a ten percent (10%) penalty. Any unpaid balance remaining after sixty (60) days of the date of the invoice (inclusive of the aforesaid penalty) shall be subject to an additional ten percent (10%) penalty.
- J. Any unpaid balance remaining as of November 1 of each year shall be re-levied on the property owner's next tax bill.
- K. If any balance is not paid in full within ninety (90) days of the date of invoice, the agreement shall terminate upon notification of the property owner by the Town."
- B. §121-29 of Article VI of Chapter 121 of the Code of the Town of Liberty is hereby amended to read as follows:
- "§121-29. Control manholes and meters.

When required by the Town Board of the Town of Liberty in its sole discretion, the owner of any property connected to and discharging into a district sewage system either (i) industrial waste, or (ii) in excess of 3,000 gallons of average daily flow of sewage in any given month, shall install at such property owner's sole cost and expense (inclusive of Town engineering and professional expenses) a manhole and flowmeter acceptable to the Town Board, the Administrator and the Town's engineer, in order to facilitate observation, sampling and measurement of waste as well as inspection by the Town. The manhole shall be located and the meter installed so as to be safe and accessible by Town personnel and constructed in accordance with plans approved by the Administrator. All maintenance, repairs and replacements thereof, and annual calibration of meters, shall be at the property owner's sole expense (inclusive of Town engineering and professional expenses) and performed by contractors approved in advance by the Town Board."

# SECTION II Effect of Invalidity

If any clause, sentence, phrase, paragraph or any part of this local law shall for any reason be adjudged finally by a Court of competent jurisdiction to be invalid, such judgment shall not effect, impair or invalidate the remainder of this local law, but shall be confined in its operation and effect to the clause, sentence, phrase, paragraph or any part thereof, directly involved in the controversy or action in which such judgment shall have been rendered. It is hereby stated to be the legislative intent that the remainder of this local law would have been adopted had any such provisions not been included.

# SECTION III Effective Date

This local law shall take effect immediately upon filing in the office of the Secretary of State.

Tom, Stacey; I am following up with some information on the aeration system we had discussed for your ditch system last week. Based on the ditch dimensions and your rated flow, it would require one Flygt 60hp submersible aerator and one Flygt 4320 5.4hp submersible mixer per ditch to provide necessary air and force to meet your permit.

The Flygt JA 317-S6-3202-614 submersible aerator is a 60hp portable unit provided with a chain sling lifting arrangement and 50ft of cable. It will provide the required air and some of the motive force needed to circulate the ditch. The data sheet is attached for your reference.

The Flygt Model 4320 5.4hp two blade mixer is required to provide the motive force required for the ditch to circulate. This unit can be supplied with a custom base to allow for insertion and removal from the ditch without dewatering. A brochure is attached

The obstacle here is cost. For one aerator and one mixer (one ditch) the budget cost is about \$130,000.00 to \$140,000.00. And I still haven't accounted for the lifting hoist or installation of the controls required to operate these devices. And you have 2 ditches during peak flow period in the summer.

The reality is the best solution is to address the screening issue for the entire plant down at the headworks structure. This would be the most cost effective, offers way better energy efficiency than adding aerators and mixers, and addresses the problem on a year round basis.

Let me know how you want to proceed. Thank you for the opportunity to look this over and to evaluate your possible options. Always happy to help.

I am in receipt of the Comprehensive Monitoring Report for #641PR30-13. The report contains Concerns and Recommendations. This letter addresses the two (2) Concerns and (1) Recommendation.

#### Concerns:

#### Section 3

At the time of monitoring it was revealed that the Invitation for Bids for general construction did not include a statement encouraging Section 3 businesses and individuals to apply

The Town mistakenly adopted NYS EFC language containing mandatory MBE/WBE participation and neglected to use the Section 3 language it has used for former Invitations for Bids. The Town will use the following language in its advertisements for construction, engineering and administrative services for its 2015 project and future projects.

"Minority and women business enterprises (MBE and WBE) and Section 3 business concerns are encouraged to respond."

#### **Contract Provisions**

The following provisions did not appear in the construction contract between the Town and Eastman Associates:

"Provisions acknowledging that all parties shall be bound by, and comply with, all applicable Federal, State, and local laws and regulations including, but not limited to 24CFR Parts 85 and 570."

The Town will include the above-noted contractual provision in future construction and professional services contracts.

## Labor Standards Compliance

At the time of monitoring, it was revealed that while the Town had assigned Mark Blauer of Blauer Associates as Labor Standards Officer, the Town had not passed a formal resolution authorizing Mr. Blauer to act in that provision.


Hi Charlie,

#### RECOGNIZE THE PUBLIC

**Richard Winters of Delaware River Solar** explained the PILOT that the Sullivan County IDA is preparing. The Board gave conceptual approval for the IDA PILOT which would begin with a \$20,000 floor and 6% revenue (voluntary). The decommissioning still needs to be met.

**Sean Zigmund** presented the following (2) documents to the Town:

To Town of Liberty, NY Board Members Dean Farrand, Russell Reeves, Vince McPhillips, Brian McPhillips, and Supervisor Charlie Barbuti:

We, the 46 (and counting) signatories and tax payers included on this letter do hereby demand the Town Board of Liberty, NY immediately and indefinitely suspend the rezoning process of 2016 based on the fact that a) the zoning map changes are against the current Town and Village Joint Comprehensive Plan, the current Town Agriculture and Farmland Protection Plan, the Sullivan County Comprehensive Plan, and New York State Agriculture and Markets Law (25 AA, section 305a which states "Local governments, when exercising their powers to enact and administer comprehensive plans and local laws, ordinances, rules or regulations, shall exercise these powers in such manner as may realize the policy and goals set forth in this article [Article 25-AA of the Agriculture and Markets Law], and shall not unreasonably restrict or regulate

farm operations within agricultural districts in contravention of the purposes of this article unless it can be shown that the public health or safety is threatened.") b) that the reasons given to the public for the rezoning are based in conjecture and there is no financial or economic data or evidence given to the public to back the Town Board's reasons, and c) the general public were not transparently involved in the process and we do not feel the changes presented will be positive for our town based on data obtained from the Town Clerk and obtained from members of the community who were questioned by our group of concerned tax payers. In fact, almost all people we've spoken to have no idea what is happening, how it is happening, where it is happening, or why it is happening.

If the town continues to proceed with the rezoning, we have no alternative than to seek legal counsel and take legal action against the town and the members of this board.

# Town of Liberty proposed zoning amendments Sullivan County

According to the AFPB, proposed amendments to the Town's Zoning Code will change the designation of 45 parcels within the Town from AC and RD to R-1. The proposed zoning change will affect 653.53 acres of land, of which, 404.35 acres are located within a county adopted, State certified agricultural district.

# Comments on proposed amendments to the Town's Zoning Code Section 147-4 Definitions

**Agri-business** – includes a number of activities, some of which have not been protected under the Agriculture and Markets Law (AML), or protected depending upon the circumstances, and/or have always been considered part of a farm operation. The town may include all of these activities as part of an agri-business, but if reviewed by the Department, protection depends upon the activity.

Activities that have never protected as part of a farm operation – bed-and-breakfasts, farm stays, farm supported businesses such as community kitchens and farm-compatible businesses. Activities that may be protected, but protection is determined on a case-by case basis – expanded road stands (not sure of the meaning here), farm markets where more than one farmer

participates in the market, seasonal events, school programs, weddings and parties, bakeries, farm stores and restaurants. Farm wineries, distilleries, cideries and breweries may or may not be part of a farm operation as defined in the AML. The Department has guidance documents on farm marketing and wineries/distilleries/cideries/breweries (copy enclosed).

Always protected – u-picks, CSAs, roadside stands/farm markets that predominantly sell products grown on the farm, corn mazes if the farm sells other farm products grown on the farm, hay rides, pumpkin patches, dairy barns, farm distilleries/farm wineries if they produce 51% of the ingredients needed to make the alcoholic beverages and, not mentioned in the definition, cideries and breweries if they produce 51% of the ingredients needed to make the alcoholic beverages. Omitted from the definition is "slaughterhouse", which may be protected if the landowner is only slaughtering their livestock.

Need to define **agri-tourism** if it is not defined in the Town Code. This activity is mentioned in the use schedule section of the draft code.

**Greenhouse, Commercial** – just a note to state that commercial greenhouses are part of a farm operation as defined in the AML. Nursery operations are also part of a farm operation as defined in the AML.

#### Section 147-5 - Enumeration of Districts

Regardless of the town's district designation, the AML protects all land, that is used in conjunction with a farm operation, from unreasonably restrictive local rules, regulations, ordinances and plans unless the municipality can demonstrate a threat to public health and safety. When drawing boundaries, planners should take into consideration where land within a county adopted, State certified agricultural district is located and make adjustments to the Code to accommodate agricultural activities on those properties. As stated by the AFPB, the R-1 Zoning District does not mention agriculture as a permitted use within that District.

**Section 147-20(B)** discusses home occupations. Under Section 147-20(B)(5)(d), commercial stables are listed as a prohibited home occupation. This should be excluded from that subsection because commercial stables, when conducted on land located within a county adopted, State certified agricultural district, are considered part of a farm operation if conditions set forth in the definitions of "commercial horse boarding operation" and "commercial equine operations" are met. These two activities are farms, not a home occupation.

# Article VII – Conservation Subdivision and Moderate-to High-Density Residential and Associated Development

One of the tenants of this Article is to wisely develop land to, among other things, protect farming and forestry. The body of the Article refers to the creation/protection of common open space. Farmland and managed forests are working landscapes and not open space.

Section 147-21(E)(4) stated that the Planning Board may seek the counsel of a registered landscape architect. If the conservation subdivision's intent is to protect farmland/forest land, the Sullivan County Soil and Water Conservation District would be better suited than a landscape architect to provide advice to the PB. Furthermore, their services are free.

It is important to target the easement holder according to the purpose of the easement. For example, Section 147-21(F)(2)(b) discusses property owners associations. They would be appropriate to hold an easement on recreational land, forever wild land or open space. They would not be appropriate to hold an easement on farmland or working forest land. They do not have the expertise to tell a farmer how to tend the land or crop and it would be difficult for a farmer to rent land from an association for a very long period of time. Furthermore, it is difficult for a municipality to hold an easement where the objective is to rent the land for agricultural purposes. This comment is based upon the inflexibility of the governmental bidding process and whether or not a long-term lease can be approved. Farmers will not put in the effort necessary to

manage and improve the land if the term of the lease is on an annual basis. Departmental experience suggests that agricultural/forest land easements should be held by agricultural land trusts or local soil and water conservation districts.

If an agricultural easement is desirable for land as part of a conservation subdivision, the Town should look at the Department's conservation easement template as a starting point for the development of a local easement.

The sections of the draft amendments concerning special use permits and site plan review is indicative of a process that is time consuming, expensive and, if applied to farm operations located within a county adopted, State certified agricultural district, unreasonably restrictive. I have attached a copy of the Department's Zoning Guideline that discusses SUPs and site plan review. There are a number of agricultural activities mentioned in the Use Schedule that require SUPs and Site Plan.

#### Area and Bulk Table

AC Zoning Districts require a lot size of 5 or more acres and the RD Zoning District requires a lot size of 3+ acres. Please note that the definition of "farm operation" in the AML does not specify acreage. Therefore, the imposition of such limits may be deemed to unreasonably restrict a farm operation located within a county adopted, State certified agricultural district.

#### Use Schedule

In general, farm operations located within a county adopted, State certified agricultural district should be a permitted use, not a special use, under the Town of Liberty's Zoning Code. The AFPB identified 45 parcels in the agricultural district that will be placed within the Town's R-1 Zoning District. Farm operations are not a permitted use within that zone. Although the AFPB discussed grandfathering, this restriction alone may accelerate the conversion of those lands to non-agricultural uses. Landowners will not have an incentive to make improvements on a farm if agricultural activities are not permitted within the zone.

Agri-business and agri-tourism in the AC and RD Zoning Districts are listed as requiring a SUP from the Town, which includes submission to site plan review. For those activities that are deemed to be part of a farm operation, the requirement to submit to SUP review and a lengthy SP review is, on its face, unreasonably restrictive in possible violation of the AML. This would not pertain to all activities listed as part of an agri-business, however, as previously discussed. Some of the activities should also be a permitted use within the R-1 Zone.

Commercial stables and riding academies in the AC and RD Zoning Districts require a SUP and SP. This in unreasonably restrictive on its face. As long as the definition of "commercial horse boarding operation" and/or "commercial equine operation" are met and the land is located within an agricultural district, the AML considers the activity to be part of a protected farm operation. A streamlined site plan review may be applied to such activities as described in the Department's Zoning Guideline. They should be a permitted use within the R-1 Zone.

Dairy, livestock and poultry farming in the RD district is allowed as a special use requiring a permit and site plan review. This is unreasonably restrictive, however, a streamlined site plan review may be applied to such activities as described in the Department's Zoning Guideline. They should be a permitted use within the R-1 Zone.

Commercial greenhouses are farm operations under the AML. They should be a permitted use within the R-1 Zone.

Nurseries and tree farms are permitted uses within the AC Zoning District and by site plan review in the RD Zoning District. A streamlined site plan review may be applied to such activities as described in the Department's Zoning Guideline. They should be a permitted use within the R-1 Zone.

Sawmills are permitted by SUP and SP. Many times, farmers contract with sawyers to bring a portable sawmill to their property to saw lumber for use on the farm and/or for sale to the public. This activity should be allowed by the Town. It is a protected activity under the AML.

WHEREAS, the District has the capacity to accept sewage above and beyond						
the amount that it presently processes from within such district; and						
WHEREAS, Outside User is desirous of establishing a connection with and						
discharging sewage into the District's sewer system from its premises located at						
, identified on the Town of Liberty tax map as Section						
, Block, Lot ("the Premises"); and						
WHEREAS, the Town and Outside User have reached an understanding						
pursuant to which the District shall permit the requested sewer connection and accept						
from Outside User sewage produced at the Premises, which understanding the Town						
and Outside User are desirous of reducing to writing.						
<b>NOW, THEREFORE,</b> it is agreed between the parties as follows:						
1. The term of this agreement shall be years, commencing as of						
, 20 and terminating on, 20						
The parties shall meet at the end of the next to last year of the aforesaid term to determine						
the possibility of a renewal term of this agreement and negotiate any changes required in						
the terms and conditions hereof. Upon the expiration of the original term of this						

agreement, in the absence of an extension of this agreement or a new agreement being entered into between the Town and Outside User, Outside User's private sewer system shall be disconnected form the District's sewer system and all connections shall be capped in a manner and by a method acceptable to and approved by the Town. Such disconnection and capping shall be at the sole cost and expense of Outside User.

- 2. Prior to connecting to the District's sewer system, Outside User shall provide to the Town and District a schedule of estimated average daily flow per month to be received by the District for the term of the agreement. Such schedule must be acceptable to the Town and District in form and content. If acceptable, a notation to such effect shall be made by the Town and District upon such schedule and it shall be attached to and be deemed incorporated in this agreement. If not acceptable to the Town and District, this agreement shall thereupon be terminated.
- 3. Prior to connecting to the District's sewer system, Outside User shall provide to the Town and District a map of the District's manhole or manholes where Outside User's private sewer line shall connect to the District's sewer system. Such map must be acceptable to the Town and District in form and content. If acceptable, a notation to such effect shall be made by the Town and District upon such map and it shall be attached to and be deemed incorporated in this agreement. If not acceptable to the Town and District, this agreement shall thereupon be terminated.
- 4. Prior to connecting to the District's sewer system, Outside User shall provide to the Town and District a written description of the type and nature of flow that is to be discharged into the District's system. Such nature and flow must be acceptable to the Town and District. If acceptable, a notation to such effect shall be made by the Town

and District upon such written description and it shall be attached to and be deemed incorporated in this agreement. If not acceptable to the Town and District, this agreement shall thereupon be terminated.

5. Prior to discharging sewage into to the District's sewer system, Outside User shall install, at his, her or its sole cost and expense (inclusive of Town and District engineering and professional expenses), the necessary connection or connections to the District's sewer system which shall include a manhole and flowmeter in order to facilitate observation, sampling and measurement of sewage flow in to the District's sewer system as well as inspection by the Town and District, all of which must be acceptable to the Town and District, the Town's Water and Sewer Department and the Town's engineer, and subject to their inspection and approval at all times during installation. The manhole shall be located and sewer connection made and the meter installed so as to be safe and accessible by Town and District personnel and constructed in accordance with plans approved by the Town and District. All installations, maintenance, repairs and replacements thereof, and annual calibration of meters, shall be at Outside User's sole expense and performed by contractors approved in advance by the Town and District. No work shall be commenced until the Town and District are provided a certificate of insurance reflecting that Outside User and/or its contractor have adequate liability insurance and worker's compensation insurance, including liability coverage for completed operations, the limits of each such coverage to be not less than \$2,000,000 in aggregate and \$1,000,000 for each occurrence, with the exception of workers compensation coverage, which shall be in accordance with and not less than statutory limits. No such policy or policies may be cancelled without thirty (30) days prior

written notice to the Town and District, and the Town and District must be named as additional insureds on each such policy. Outside User shall be responsible to obtain all necessary permits for the work from any and all governmental agencies having jurisdiction, all at Outside User's sole cost and expense.

- 6. In the event the Town and District determine in their sole discretion that the District does not have sufficient capacity to continue to accept sewage from Outside User and simultaneously meet the needs and requirements of the in-district users, a written notice of termination of this agreement will be sent to Outside User. Such notice shall establish an effective date of termination, which shall be not less than twelve (12) months and not more than eighteen (18) months after the date of such notice.
- 7. The initial charge for each 1,000 gallons of sewage flow received by the District shall be \$\_\_\_\_\_\_. The Town and District may increase such charge from time-to-time during the term of this agreement upon thirty (30) day's advance written notice to Outside User, provided that such new charge shall not exceed the average residential rate charged to in-district users, which includes Maintenance and Operation (M&O) and Capital charges.
- 8. Outside User shall be billed quarterly based on the actual flow recorded by the aforesaid meter as read by personnel of the Town and District. In the event any amount billed by the Town remains unpaid after thirty (30) days of the date of the invoice, Outside User shall pay a ten percent (10%) penalty. Any unpaid balance remaining after sixty (60) days of the date of the invoice (inclusive of the aforesaid penalty) shall be subject to an additional ten percent (10%) penalty. If any balance is not paid in full within ninety (90) days of the date of invoice, this agreement shall terminate

upon notification of the property owner by the Town. In any event, any unpaid balance remaining as of November 1<sup>st</sup> of each year (inclusive of all penalties) shall be re-levied on Outside User's next County-Town tax bill.

- 9. Except as may otherwise be set forth in this agreement, Outside User shall at all times comply with all provisions set forth in the Town's sewer use regulations set forth in Chapter 121 of the Code of the Town of Liberty and the rules and regulations promulgated pursuant thereto, including any and all amendments that may hereafter be made thereto, all of which are incorporated herein by reference.
- 10. Outside User shall defend, indemnify and hold harmless the District and the Town from any and all damages and expenses incurred by the District and the Town, including but not limited to all reasonable professional fees (i.e. attorney's fees and engineer's fees), by reason of any breach by Outside User of this agreement or violation by Outside User of the Town's sewer use regulations.
- 11. In accordance with the provisions of Section 109 of the General Municipal Law, Outside User is prohibited from assigning, transferring, conveying, subletting or otherwise disposing of this agreement, or its rights, title or interest in this agreement, or its power to execute this agreement, to any other person, corporation or entity, without the prior written consent of the Town and District.
- 12. Each and every provision of law and clause required by law to be inserted in this agreement shall be deemed to have been inserted herein. If any such provision is not inserted through mistake or otherwise, then upon application of either party, this agreement shall be physically amended forthwith to make such insertion.

13. Any and all notices, billings and payments required hereunder shall be addressed to the parties at their respective addresses set forth at the beginning of this agreement, or to such other address as may hereafter be designated in writing by any party. Such notices, billings and payments shall be transmitted by ordinary first class mail and shall be deemed given when mailed. Mailing shall be deemed to have occurred

on the date of the postmark.

14. No waiver of any breach of any condition of this agreement shall be binding unless in writing and signed by the party waiving such breach. No such waiver shall in any way affect any other term or condition of this agreement or constitute a cause or excuse for a repetition such breach or any other breach unless the waiver shall expressly include the same.

15. This agreement constitutes the complete understanding of the parties hereto. No modification of any provisions hereof shall be valid unless in writing and signed by all parties.
