LOCAL LAW No. **3** of 2024

TOWN OF LIBERTY, SULLIVAN COUNTY, NEW YORK

A LOCAL LAW TO AMEND THE TOWN OF LIBERTY ZONING LAW

Be it enacted by the Town Board of the Town of Liberty as follows:

Section 1. Legislative Intent.

The Town of Liberty enacts this local law pursuant to Section 10 of the Municipal Home Rule Law and Article 16 of the Town Law to provide for the orderly development of the Town and to protect the health safety and welfare of its residents. Consistent with the purposes of the Resort Hotel (RH) district, this local law adds several parcels to this district to support a diversified tourism industry and the Town's economic base. This law also includes related adjustments to the Schedule of District Regulations and Zoning Map.

Section 2. Amendment of Article II, § 147-4. Definitions.

The definition of "Destination Resort" is hereby removed and replaced with the following:

DESTINATION RESORT

A self-contained development that provides visitor-oriented accommodations, developed recreation facilities and appropriate support services. Developed recreation facilities may include, but are not limited to, golf courses, tennis courts, swimming pools, ski runs, bicycle paths and similar facilities. Visitor-oriented accommodations include overnight lodging, restaurants, meeting facilities, entertainment venues, gaming casinos, and similar uses. A destination resort may contain residential dwelling units.

Section 3. Amendment to the Zoning Map pursuant to §147-6 of the Town Code

The Official Zoning Map of the Town of Liberty is hereby amended as follows. The following parcels, totaling approximately 938 acres, shall be added to the Resort Hotel (RH) District, listed by Section, Lot, Block numbers:

23-1-117; 30-.1-5; 23-1-78.2; 23-1-123.1; 30-1-4; 23-1-121.5; 30-1-1.1; 23-1-112.3; 29-2-3; 23-1-87; 26.-1-59

Section 4. Amendment of Schedule of District Regulations

The Schedule of District Regulations incorporated by reference in §147-8 and attached to the Zoning Law is amended as follows.

In the Resort Hotel (RH) District, under the Principal Permitted Use column, the following use is removed:

“Boarding or tourist homes”

In the Resort Hotel (RH) District, under the Special Use column, the following uses are removed:

“Recreational vehicle parks and campgrounds”

“Summer camps”

“Shooting ranges”

“Mobile homes for single-family use, but not including mobile home parks”

In the Resort Hotel (RH) District, under the Special Use column, the following use is added:

“Destination Resort”

Section 5. Severability.

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgement shall be confined in its operation to the part of provision or application directly involved in the controversy in which judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Town hereby declares that it would have passed this Local Law or the remained thereof had such invalid application or invalid provision been apparent.

Section 6. Supersession.

This Local Law is adopted pursuant to the provisions of the Municipal Home Rule Law of the State of New York and is intended to supersede any provisions of the New York State Town Law, the Town of Liberty Zoning Law and the General Municipal Law which are inconsistent with the provisions of this Local Law.

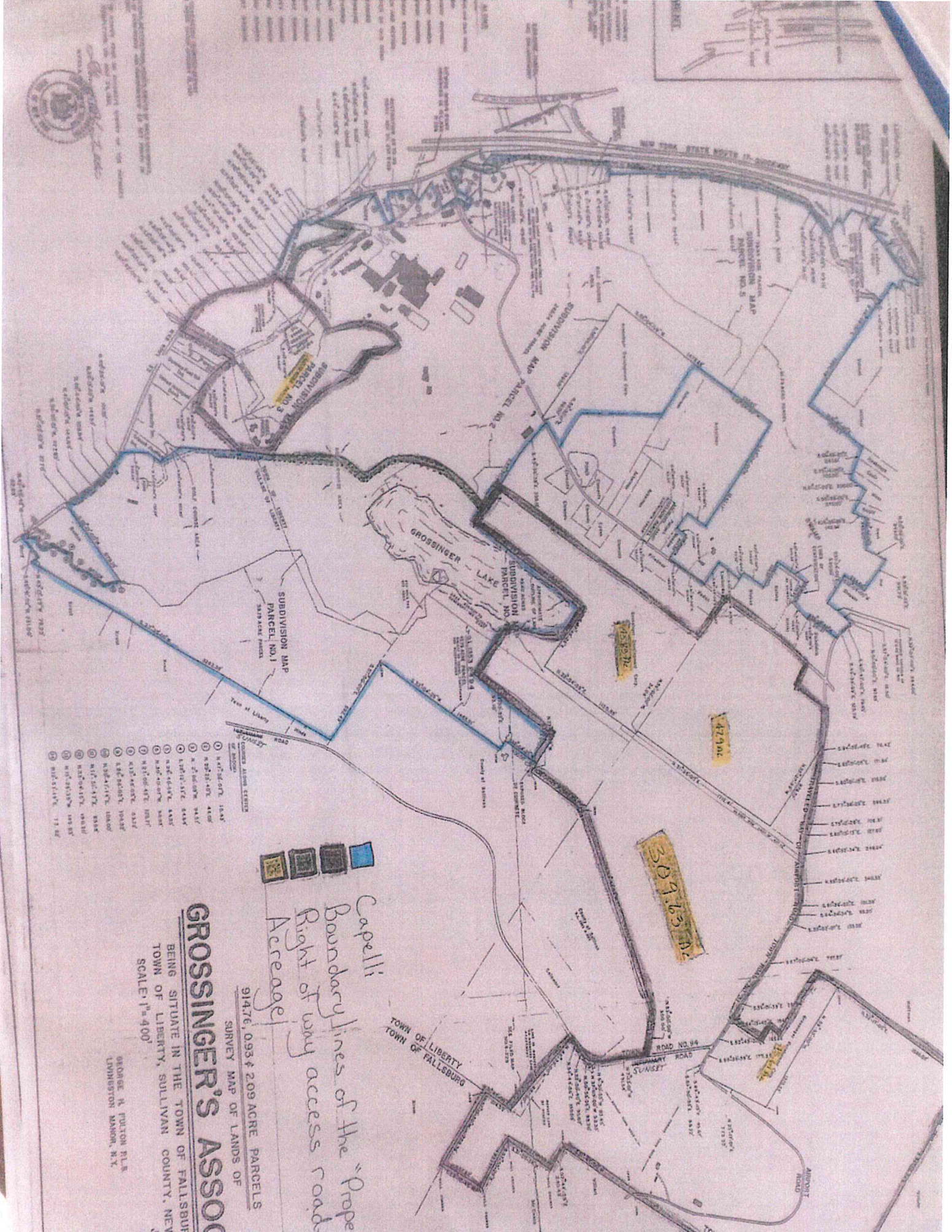
Section 7. Effective Date

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

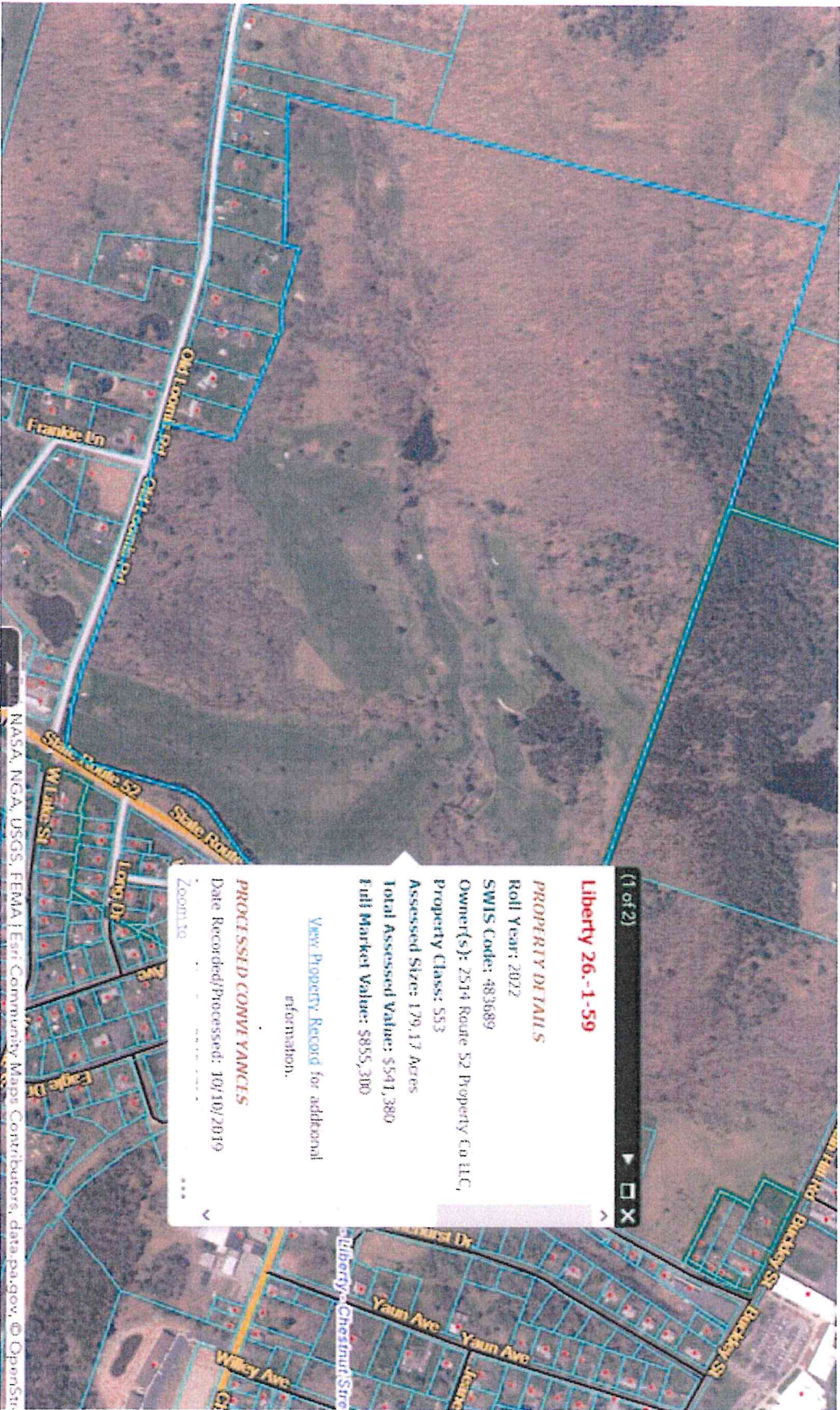

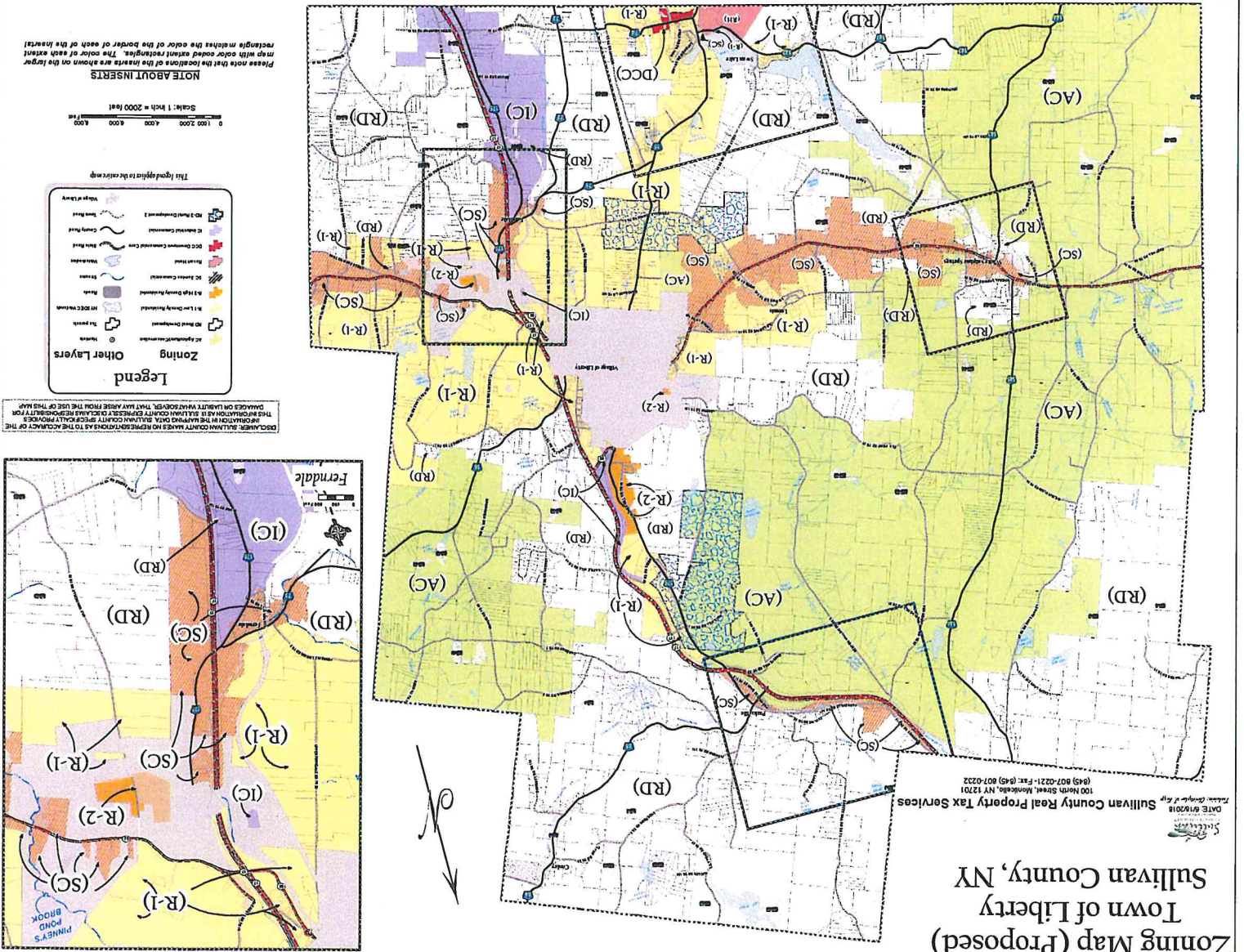

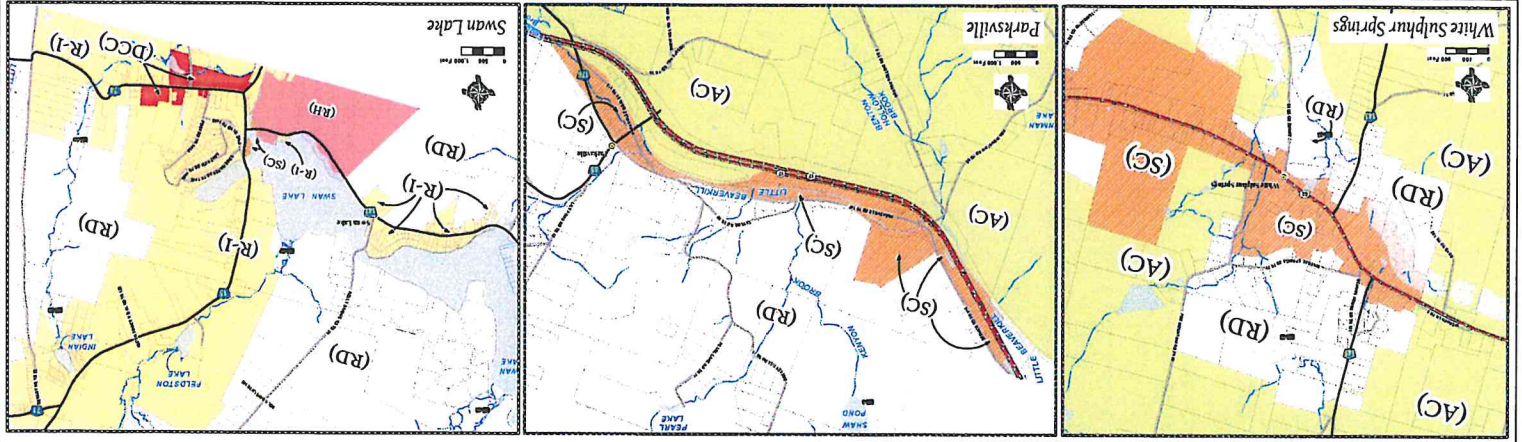
